Our school is participating in a special provision under the National School Lunch Program, either the Community Eligibility Provision (CEP) or Provision 2 (P2). The CEP and P2 provisions are directed toward schools with a high percentage of economically disadvantaged students. Under CEP and P2 all students receive a breakfast/lunch at no charge for the entire school year. However, to determine eligibility to receive additional educational benefits for your child(ren) you will need to complete an Income Verification Form. Completion of this form is voluntary and will only be used for the purpose of determining eligibility for additional educational benefits.
