ESSA languages: English, Arabic, Chinese, Dari, Gujarati, Hmong, Karen, Korean, Marshallese, Pashto, Spanish, Ukrainian, Urdu, and Vietnamese

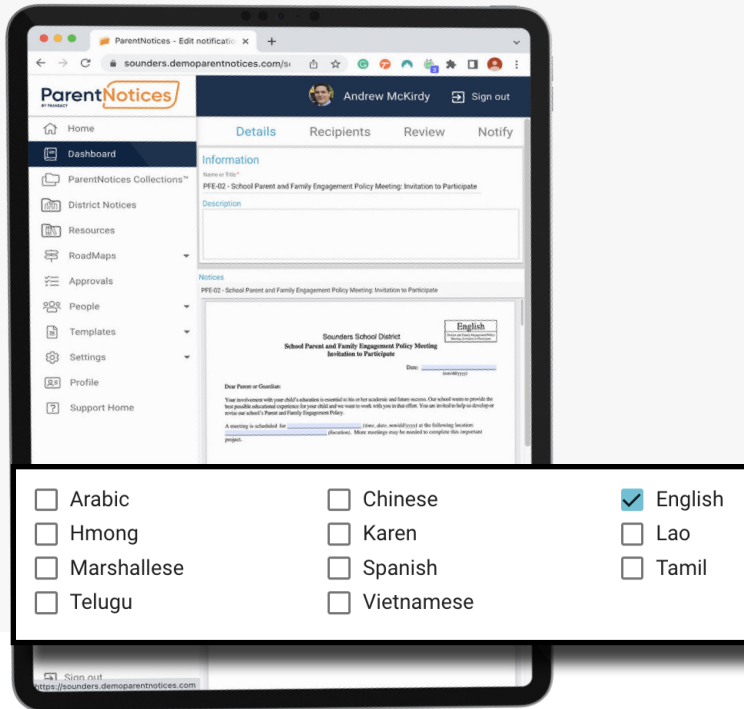

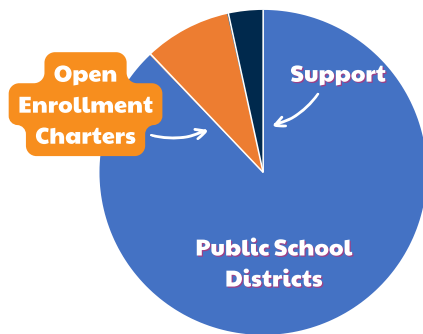
