## AAEA Highly Effective School Leadership (HESL) Certification Program Overview 2021-2023

Creation:	This program is designed to equip and prepare building level principals to lead their school through a school improvement process. It provides support for principals during their first years.
Program:	Participation in this two-year program is voluntary.
Administration:	HESL is administered by the Arkansas Association of Educational Administrators in coordination with districts across the state, the Arkansas Department of Education, and Solution Tree.
Requirements for Applying:	Applicants must be serving as building principals in 2021-2022. Additionally, applicants must have completed the Beginning Administrator Induction Program (Yr 1).
Superintendent and Principal Role:	For an applicant to be considered for participation, the superintendent must complete the recommendation section of the application and sign the statement of support.
Applicant Role:	Applicants must attend and actively participate in all scheduled trainings and advisory zooms that will be held twice each month. Not attending or actively participating in these requirements could result in dismissal from the program.
Selection Criteria:	Applicants who have completed BA Yr 1 and are beginning their first year as principal will have first priority. Deadline for receipt of completed applications is May 28, 2021. Program Certification:	Upon completion of the two-year program, participants will receive Highly Effective School Leadership certification and will have the option of obtaining building level Highly Effective School Accreditation (HESA).
Expenses:	AAEA will provide meals/snacks, books, and training materials. Travel will be at the expense of the participant or her/his district.
